Cart Waiver

As a member of a Wellman Golf Club facility (Hereinafter Lessor) you will be entitled to lease a golf cart for use at the Wellman Golf Club in accordance with the terms and benefits of your membership agreement. Each time you use a cart at the Wellman Golf Club you are a Lessee of the golf cart and you agree to return the cart to the Lessor in the same condition as received ordinary wear and tear excepted. Lessee(s) agrees to reimburse the Lessor for the full cost of repairing any damage to golf cart. Lessee(s) further agree, at their sole cost and expense, to defend, indemnify and hold harmless Lessor from and against all suits, claims and demands, to include attorney fees and costs, caused by the use of said golf cart while in Lessee(s) possession. Lessee(s) represents he/she is at least 16 years of age, has a valid driver's license and understands how to safely operate the golf cart. If the cart does not operate properly at any time, cease operation immediately and report condition to an employee of Lessor.

Members may use a private cart with proof of insurance and appropriate turf tires. The cart must be inspected by the Club Manager before using any non-club vehicle on the course.

Payment of Membership Account

Monthly member agrees that payment of dues, made in accordance with the Wellman Golf Club Membership Agreement, shall be due and owing on the **1st** of each month. Dues will be automatically charged against the card listed on this application by the **5th** of each month. Valid payment by check shall be considered delivery by Member and receipt by Wellman Golf of a check upon which sufficient funds may be drawn to satisfy the monthly charges then due and owing. By signing below, Member hereby authorizes the Wellman Golf Club to charge the credit/debit account pledged on the Applicant Information section of this Member Application. Member further agrees that in the event he/she fails to pay said monthly charges when due, for whatever reason, by the end on the calendar month in which the monthly charges have been billed, the Member's account will become delinquent. The Member agrees that in the event the Member's account becomes delinquent, he/she shall pay, in addition to the delinquent monthly charges, a penalty equal to five (5%) percent of the total delinquent monthly charges until paid.

Resignation Policy

Applicant may resign from the Club by giving written notice to the Club, the effective date of a resignation will be thirty (30) days after the date the Club receives Applicant's written notice. All accrued dues for which the Applicant is liable are due upon the effective date of resignation.

Applicant Authorization

By signing below, if elected to membership, I agree to abide by all rules and regulations now in effect at the club and any amendments thereto which may be made from time to time. I agree to be responsible for the charges incurred by myself or my family during our membership according to the club's by-laws and all costs of collection to include attorney fees. I understand that these rates are based on a 12-month financial commitment, and I will pay until I give the required 30 days resignation notice. Tax is not included in Memberships. Any member who resigns from the club during the annual term and subsequently wants to rejoin the club can do so only after paying all back dues and fees from the balance of that annual term. All dues are billed in advance. Prices are subject to change.
